March 3—Last day for any committee action on legislation

March 8—Last day of session

April 16—Reconvened Session

December 4—The standing committees of the General Assembly shall complete their consideration of all legislation continued by them from the 2008 Regular Session no later than midnight.

December 8—Requests for drafts of any bill or joint resolution to be prefiled shall be submitted to and received by the Division of Legislative Services no later than 5:00 p.m.

January 9—Requests for redrafts and corrections of any draft prepared for prefiling shall be submitted to and received by the Division of Legislative Services no later than 5:00 p.m.

January 9—Requests for the drafting, redrafting, or correction of any bill or joint resolution creating or continuing a study shall be submitted to and received by the Division of Legislative Services no later than 5:00 p.m.

January 13—Requests for the drafting, redrafting, or correction of any bill required to be introduced by the first day of the session that will not be offered for prefiling shall be submitted to and received by the Division of Legislative Services no later than 5:00 p.m.

January 14—Bills and joint resolutions offered for prefiling shall be prefiled in either house no later than 10:00 a.m.

January 14—Session begins.
